The prescription is then called into the member's pharmacy and the patient may pick it up immediately.

With the growing popularity of consumer-directed health plans, TelaDoc offers a quality, cost-effective delivery system for routine health care. Since TelaDoc consultations are provided for a flat fee, the TelaDoc service integrates well with most consumer-directed health plans. In addition, TelaDoc includes an electronic health record that is available free of charge to both patients and physicians.
